EGG DONATION + SURROGACY STANDARD PACKAGE SCOPE OF THE CLINIC, COUPLE & SURROGACY AGENCY AGREEMENT

HEREINAFTER.

The potential parents are identified as "couple". The Batumi IVF Clinic, located in 122 Airport Street Batumi, Georgia, which will provide the necessary treatment to the couple, is identified as "clinic". The person/s which will donate the reproductive cells will be identified as "donor/s". The potential surrogate mother which will receive the embryos will be identified as "surrogate mother". The establishment,, that will handle the execution of all the administrative transactions between the couple, clinic, and the surrogate will be identified as the "agency".

1.SUBJECT

The clinic, will cultivate embryos from the reproductive cells of the donor and transfer them to the surrogate mother. This document determines the scope of the treatment that the clinic will provide, and the amount and the schedule of the payments the couple will pay in exchange for the treatment.

2. SCOPE OF THE EGG DONATION + SURROGACY STANDARD PACKAGE

The package covers all the following:

- 2.1 Guaranteed number of treatment: 2
- 2.2 The tests which will be done on the father candidate
- 2.3 The freezing of the sperm cells (if necessary)
- 2.4 The costs incurred in identifying the appropriate donor
- 2.5 The costs incurred in identifying the appropriate surrogate mother
- 2.6 The costs incurred in the formation of the contract between the couple and the surrogate mother
- 2.7 The costs incurred in the formation of the contract between the couple and the agency
- 2.8 Other administrative costs before the treatment
- 2.9 The notary costs

- 2.10 The costs incurred in conducting all the medical examinations and other diagnostic tests for the donor before the treatment.
- 2.11 The medicinal costs of the donor during the stimulation treatment.
- 2.12 The medical examinations of the donor during the stimulation treatment.
- 2.13 The costs incurred in the oocyte collection
- 2.14 The costs incurred in the microinjection
- 2.15 The costs incurred in the embryo culture treatment
- 2.16 The costs incurred in the freezing of the embryos acquired as a result of the stimulation treatment.
- 2.17 The costs incurred in the diagnostic tests of the surrogate mother before the embryo transfer
- 2.18 The medicinal costs of the surrogate mother before the embryo transfer
- 2.19 The costs incurred in the thawing of the first 1 & 2 party and the second party embryos
- And The costs incurred in the embryo transfer
- 2.20 The costs of the pregnancy tests
- 2.21 The costs incurred in the periodical briefings on the pregnancy
- 2.22 The medical examinations of the surrogate mother associated with the pregnancy
- 2.23 The transportation and accommodational costs of the surrogate mother
- 2.24 The medicinal costs of the surrogate mother associated with the pregnancy
- 2.25 The living costs of the surrogate mother
- 2.26 The rehabilitation compensation that the surrogate mother will receive ten days after the childbirth
- 2.27 The post-childbirth administrative costs
- 2.28 The costs incurred in the reception of the couple by a clinic representative at the border or airport and their transportation to the clinic.
- 2.29. The living costs of the couple
- 2.30. A mobile-smart phone for the couple with Georgian GSM operator
- 2.31. The transportational costs within Batumi until 10th day after the childbirth
- 2.32 The costs incurred in transporting the couple to the airport on the day of return.

3. THE PAYMENT PLAN

- 3.1 The total cost of the Egg Donation + Surrogacy Package costs **32.000 USD.**
- 3.2 The couple pays **6000 USD** on the day the contract is signed. If the payment will be executed through a bank, the couple will incur any costs associated with the transaction.
- 3.3 If the couple demands the rescission of the contract and the treatment has already begun, the 4000 USD portion of the 6000 USD payment stipulated above will not be repaid.
- 4.4 If the pregnancy test turns out to be positive, the couple makes an additional payment of **8000 USD**.

- 3.5 The couple makes the third payment of **2000 USD** on the 8th week of the pregnancy.
- 3.6 The couple makes the fourth payment of **2000 USD** on the 16th week of the pregnancy.
- 3.7 The couple makes the fifth payment of **2000 USD** on the 24th week of the pregnancy.
- 3.8 The couple makes the sixth payment of **2000 USD** on the 32th week of the pregnancy.
- 3.9 The couple makes the seventh and final payment of **10000 USD** on the condition that the baby is alive 10 days after the birth.
- 3.10 At the request of the couple, the results of the pregnancy tests, or the periodical medical briefings on the pregnancy could be sent to the couple through e-mail or fax.
- 3.11 If the pregnancy test turns out to be negative and the transfer of second party embryos are underway (in other words, when the treatment recommences), the couple does not make the payments stipulated in clauses 3.2 and 3.4 a second time. Instead, the couple continues from 3.5 and onward
- 3.12 The previous clause 3.11 also applies in cases where the pregnancy that has resulted from the first party embryo transfer ends in a miscarriage or stillbirth.
